- Level 1 undergraduate sequence assessment fee (including undergraduate bridging program) is charged only once where the sequence is identical, for example the assessment of the identical Level 1 sequence within six different undergraduate degree program titles results in one fee
- Level 2 sequence assessment fee is charged once for Honours programs where the program is identical, and once for Graduate Diploma programs where the program is identical, for example the assessment of the identical Level 2 sequence within six different Honours degree program titles results in one fee
- Packaged Level 1 and 2 undergraduate sequence assessment fee (including undergraduate bridging program) is charged only once where the sequence is identical, for example the assessment of the identical Level 1 and 2 sequence within six different undergraduate degree program titles results in one fee
